The Board also discussed the replacement of the three Crape Myrtle trees located on Pointed Oak across from Braypark Lane. This item was tabled until spring 2016, The Board requested that LandCrafters remove the dead Crape Myrtles.

#### Other Business

**Architectural Control Committee** – The Board requested that the Association's Attorney draft a ACC Guidelines for the community.

**PLAYGROUND REPAIRS** – The Board requested that McKenna Construction come out and inspect the playground and provide a quote for adding Kiddie Cushion to the playground.

**COMMUNITY COMMUNICATIONS** – The Board discussed the web design & development of mobile website and SMS Alert System, Following discussion, the Board decline to approve the proposal for the SMS Alert System and agreed to reconsider the proposal for the mobile web site next year.
